

## COSTUMER DATA PROTECTION CAR WASH SHOP

## 1. DATA CONTROLLER

## 2. LEGAL BASIS AND PURPOSE OF PERSONAL DATA PROCESSING

- 2.1. CAR WASH SHOP collects and processes user personal data based on:
- user consent, to provide services and fulfill pre-contractual conditions or contractual obligations (e.g. publishing ads, helping the user, establishing contacts between sellers and buyers, storing the user's favorite search criteria, storing the user's popular advertisements, individualized display of content or advertising messages website users, etc.),
- based on their legitimate interests (e.g. website operation and management, business management, service improvement and offering new services to providers, user relationship management, etc.)
- or when required by law (e.g. prevention of illegal work Law on prevention of illegal work and employment, at the request of law enforcement authorities Law on criminal procedure, for civil procedure Law on civil procedure, etc.).
- 2.2. Website users allow the use and processing of personal data based on individual consent, in such a way that when creating a user account or after the first login to the user account after the implementation of the legal notice, they confirm this by clicking "I agree". By clicking on "I agree", users allow that personal data to be used in the manner and for the purposes specified in this document, i.e. are an integral part of the legal notice.

## 3. CATEGORIES OF PROCESSED PERSONAL DATA

- 3.1. CAR WASH SHOP processes the following user personal data:
- name, surname, or official title,
- address.
- email address,
- phone number,
- access password.
- IP and date of access to the subpage http://www.moj.carwash.shop

Whereby to provide services, fulfill pre-contractual and contractual obligations, and perform basic activities, i.e. publication of ads, CAR WASH SHOP processes e-mail address, phone number, access password, IP address, and date of access to the sub-site <a href="http://www.carwash.shop">http://www.carwash.shop</a>, for the procedure to prevent illegal work, name, surname or official title and us.

- 3.2. The user agrees that to fulfill the legal obligation, the date and time of advertising and the IP number, i.e. the address of origin, and that in case of suspicion of illegal use, a criminal offense or criminal prosecution of that offense is necessary, the said data is forwarded to the competent persons of the service.
- 3.3. CAR WASH SHOP also collects non-personal data about the use of the website, especially data on which sub-pages are most visited, how many visitors visit these sub-pages per day and how long visitors stay on them, individual sub-pages, i.e. "cookies". Users allow the collection of data about the use of the website by clicking "Continue", which appears on the website with a "cookies" notification. # 4. PERSONAL DATA PROCESSORS

- 4.1. CAR WASH SHOP forwards the user's data to contractual partners who act as processors of personal data, whereby it undertakes to enter into such a contractual relationship only with contractual partners who have taken appropriate measures to protect personal data.
- 4.2. CAR WASH SHOP does not transfer personal data outside the EU or to international organizations, except to the extent that this is necessary and if there is a decision on eligibility or based on relevant contractual clauses, which provide safeguards for such transfers.

#### 5. STORAGE PERIOD OF PERSONAL DATA

5.1. The user's data is stored for <u>12 months</u> from the user's last login to the system, i.e. for the time required by our legal obligations.

#### 6. USER RIGHTS

- 6.1. The individual to whom the personal data refers (i.e. the user) has, by the provisions of the General Data Protection Regulation and the applicable Personal Data Protection Act, the right to:
- requires access to personal data,
- request deletion or correction of personal data,
- requires limitation of personal data processing,
- revoke your consent at any time (without affecting the legality of data processing on
- the basis of consent used until its cancellation),
- object to the processing of personal data at any time,
- requires the transfer of data, including the transfer of personal data to other organizations, in an electronically readable format form,

- 6.3. If the administrator suspects abuse of the rights belonging to the user, especially the right to delete personal data, the operator reserves the right to prevent the user from re-registration.

# 7. LIMITATION OF MANAGER'S LIABILITY

- 7.1. CAR WASH SHOP to personal data directly exchanged by website users (eg seller and buyer) does not access and is not responsible for them.
- 7.2. CAR WASH SHOP undertakes to always protect personal data with the highest degree of care and by the provisions of the Personal Data Protection Act and the General Data Protection Regulation in force at any time.
